I will be fully insured to cover damage to other craft and personal liability. Whilst I appreciate that every effort will be made to ensure everyone's safety, I understand that ultimately, I alone am responsible for deciding whether or not my abilities are sufficient to allow me to go or stay out on the water at any given time during this event. In matters of safety, I will err on the side of caution, and I recognize that I will be sailing entirely at my own risk.
