1. Rules

- 1.1 The Regatta will be governed by the rules as defined in the *Racing Rules of Sailing*.
- 1.2 The Rules of the Wayfarer International Class Association will apply.

2. Eligibility

- 2.1 The Regatta is open to all boats meeting the Wayfarer International Class Association Requirements.
- 2.2 All skippers must be members in good standing of the Wayfarer Class Association.
- 2.3 Eligible boats may register from 900 to 1030 EDT Saturday, Sept 11, 2021

3. Fees

The registration fee for the East Coast Championship Regatta is **\$55.00 USD**

4. Schedule of Racing and Events

- 4.1 East Coast Championship: Saturday Sept. 11, and Sunday Sept.12, 2021
 - 4.1.1 Saturday 9/11/2021 1100 hrs: Competitors' Meeting
 - 4.1.2 Saturday 9/11/2021 1200 hrs: Warning Signal of first of up to 4 races.
 - 4.1.3 Sunday 9/12/2021 1000 hrs: Warning Signal of first race.
 - 4.1.4. Sunday 9/12/2021 No warning signal after 1300!

5. Sailing Instructions

- 5.1 The Sailing Instructions will be available at registration

6. Venue

- 6.1 The course will be located within Tawas Bay approximately 0.5 to 1.5 nm WNW of the Tawas Bay Yacht Club.

7. The Course

- 7.1 The course will be windward/leeward, twice around as described in the Sailing Instructions. A gate at the leeward mark may be used.

8. Scoring

- 8.1 When 4 or more races have been completed, a boats series score will be the total of her scores, excluding her worst score.
