Minutes

- 1. Chair's Welcome
 - Mike Codd welcomed the members to the meeting, and asked those present to introduce themselves.
- 2. Adoption and Approval of 2013 AGM Minutes
 - Motion to approve as presented (Scott Ramsay, seconded by Allastair Ryder-Turner); approved. No business arising.
- 3. 2013 Yearbook DVD status
 - Uncle Al has them and they will be distributed to those in attendance.
- 4. Membership Status
 - Kit Wallace presented the membership report: there were 83 members, including 7 honorary members in 2013. Kit responded to some questions about how the numbers compare to recent years: they are down some.
- 5. 2013 World's Wrap-up
 - Rob Wierdsma reported that feedback received on the regatta has been overwhelmingly positive;
 - the participation was lower than expected;
 - the final financial report will be issued at the MSC AGM, which is upcoming;
 - the sale of the Mark IVs at the end of the regatta was also good news for the fleet;
 - a list of lessons learned would be helpful for future organizing committees;
 - there was some discussion of reasons why the number of participants from the UK was lower than expected;
 - a note of thanks was extended to the Organizing Committee for all their effort;
 - thanks were also extended to the race committee.
- 6. Class Rule Changes
 - no changes have been proposed.
- 7. Financial Report for 2013
 - Mike Codd presented the financial report;

- Income from memberships was down, but there were some donations that brought the total income up compared to 2012;
- net expenses on the AGM were up compared to 2012 but within an acceptable amaount;
- boat show costs were down, but there are some outstanding expenses for new signage;
- equipment expenses included a new scanner for Uncle Al, calibration of the scale, fabrication of an aluminum frame and a stamp for measurements;
- membership dues to the WIC is outstanding;
- publications and Wayfarer books came in at net surpluses for the year;
- total expenses were down compared to 2012 for a net income of ~\$1000 for the year; there are some known outstanding accounts payable that will eat up the surplus;
- total assets to date are up at ~\$4700;
- Mike moved approval of the financial report (seconded by Peter Rahn): approved
- Mike moved that the annual dues for 2014 (for any that have not already been paid) be increased to \$35 (seconded by Peter Rahn); there was further discussion of the appropriate amount to sustain the finances of the association (\$35 vs \$40);
- Motion to amend the motion \$40 instead of \$35 (Jan d'Ailly, seconded by Sue Pilling); there was further discussion of the value of membership in the Association to sailors, especially those who are not active racers; the amendment was approved;
- The amended motion to increase the fees was approved;
- There was a suggestion that the Executive should consider alternative membership options for non-participants before the next AGM;
- 8. Executive for 2013
 - Mike Codd expressed his interest in no longer being holding the Chair; he would retain the treasurer role;
 - we are looking to refresh the executive with some new representation from the membership;
 - Mark Taylor has stepped down as member-at-large; John deBoer has also stepped down;
 - Uncle Al mentioned some roles that could benefit the executive, including a vice-chair, librarian/archivist (Sue and Steph expressed willingness to take on the job);
 - anyone who would like to volunteer can speak to Mike or Uncle Al;
- 9. New Business
 - a. Discussion of methods to increase class participation (Hartley and Classic divisions debate)
 - Mike explained the context and rationale for the motion that was approved at the Executive in November 2013;
 - Uncle Al posted a forum on the Whiffle Web to gauge the response of the membership to the idea of recognizing both Hartley and Classic finishes;
 - Mike invited Tom Wharton and Heider Funck to present the issue as they see it;
 - There was lots of discussion of the merits of dividing the fleet by mark of boat versus creating divisions based on the experience and skill of sailors; what is more likely to increase participation class regattas?
 - Mike reiterated the point that there is no intention to create two sets of class championships, but rather there is interest in doing things that will increase participation in regattas;
 - Motion to affirm that all Wayfarers will race as a single fleet (moved by Jan d'Ailly, seconded by Rob Wierdsma); approved
 - the Executive is tasked with considering initiatives that will encourage participation in regattas;
